LOCATION

The Margaret River Airstrip is situated approximately 3.5km to the north east of the Margaret River Town Centre. Access is from Bussell Highway via Nozzle Road.

LIGHTING

NO general aviation night landings or take offs permitted without the Shire's prior approval.

PAL – 120.25MHz VHF.

TERMINAL FACILITIES

Transfer station for RFDS patients only.

Portable toilet available.

AIRCRAFT PARKING

Hardstand area has been provided to the north of the general aviation apron. Tie down facilities are available.

Note: under no circumstances are private aircraft to park on apron reserved for RFDS.

AIR TRAFFIC CONTROL

HANGARS

Hangars are not available.

AIRCRAFT REFUELLING SERVICE

None available. Access to airstrip for private refuelling operations to be arranged by contacting Council's contact officer during normal working hours 0700-1600 (AWST).

Refuelling to be undertaken in accordance with Civil Aviation Order, Part 20, Section 20.9, Issue 6 'Air Service Operations – precautions in refuelling, engine and ground radar operations'.

SAFETY PROCEDURE

Fly over of signal area is required prior to landing. No straight in approach.

Pilots are advised that kangaroos may be present on the airstrip and that it is their responsibility to ensure that the aerodrome is suitable for aircraft operations.
