Cover shall commence from the time the Covered Person leaves their normal place of residence and travel directly (as defined) to their normal		



place of employment. Cover ceases upon arrival at place of normal employment. Cover will re-commence for the return journey from the Covered Persons normal place of employment to travel directly to their normal place of residence and shall cease upon arrival at normal place of residence. A journey also extends to include cover for activities undertaken during lunchtimes and meal breaks. Travel directly means travel to and from the Covered Persons normal place of residence or normal place of employment and shall include any minor deviations or interruptions which in no way increase the risk of bodily injury that would have normally arisen had the person travelled directly without deviation or interruption.

'Indemnity Cover' (as defined in the Trust Deed) arranged on behalf of the Member, \$20,000,000 inclusive of 'Pooled cover any one event and in the aggregate across all Members of the Scheme.
