Cemeteries Act 1986, Cemetery Local Laws 2019

In accordance with the *Cemeteries Act 1986*, the Grant initially entitles the holder the right of burial in a specified area of a cemetery and the right to place a memorial on that area for a term of 25 years. A further term of 25 years will be granted if an application to renew the Grant is made and the appropriate fee paid.

A right of burial granted under the Cemeteries Act 1897 or renewed under section 25(2) of the Cemeteries Act 1986 may, if the Board and the holder for the time being of the grant agree, be renewed from time to time for a further term not exceeding 25 years in the case of any one renewal.

Where there is more than one beneficiary following the Grant of Probate of Will, or the original Grant has expired, the Statutory Declaration attached is to be completed; to the effect that the applicant is acting with authority and that there is no other person to their knowledge having a greater claim.
