Terms and Conditions

The home compost system rebate is available to Shire of Augusta Margaret River residents only.

Items purchased as part of the rebate will not be provided as gifts or sold to others.

The home compost system rebate is available for the purchase of new products only. The rebate does not cover the purchase of replacement parts.

The home compost system rebate does not cover the purchase of composting accessories - for example: live worms, compost bedding, aerating tools, compost starters.

The Shire does not have home composting systems available for purchase. Residents must purchase a home compost system from external retailers.

The Shire will honour receipted purchases of eligible home composting systems made within 6-months of purchase.

Households are limited to two different types of home composting systems within a 5-year period - for example, in 2025 you may apply for a rebate on a compost bin and in 2026 you may apply for a rebate on a bokashi bucket).

A photo/scanned copy of a government issued photo identification document must be provided as part of your application (for example, driver's licence or passport).

If your photo identification document does not include your current residential address, a document confirming proof of residency must be provided as part of your application.

A photo/scanned copy of your purchase receipt must be provided as part of your application.

Rebate payments may take up to 4 weeks to process, funds will be transferred electronically into the nominated bank account only.

The Shire has the right to decline incomplete/non-conforming applications.

The Shire has the right to request further information if deemed necessary.

The Shire has a set budget for home composting rebates each financial year. Once the budget is exceeded, we cannot issue further rebates.
