**Pensioner concessions** can only be applied on presentation of a current Pensioner Concession Card, State Concession Card, Veteran's Card or a Senior's Card together with a Commonwealth Senior's Health Card.

**Sterilised fees** will apply upon presentation of either of the following:

- Veterinary Surgeon's Certificate of Sterilisation;
- Signed Statutory Declaration; or
- Shire officer sighting dog's ear tattoo and confirming sterilisation.

The fee payable for registration of a **Declared Dangerous Dog, Restricted Breed Dog or Commercial Security Dog** is \$50.00. Concessions do not apply to these fees and registration must be renewed annually.

The fee payable for registration of a **Working Dog** (a dog that is *bona fide* used in the droving or tending of stock) is 25% of the fee that would otherwise be payable.
