<p>The fee payable for registration of a Declared Dangerous Dog, Restricted Breed Dog or Commercial Security Dog is \$50.00. Concessions do not apply to these fees and registration must be renewed annually.</p>						
<p>The fee payable for registration of a Working Dog (a dog that is <i>bona fide</i> used in the droving or tending of stock) is 25% of the fee that would otherwise be payable.</p>
