Cats Exempt from Registration
<p>A cat that is in the custody of any of the following is exempt from registration –</p> <ul style="list-style-type: none"> <li>• Cat Welfare Society Inc, trading as ‘Cat Haven’</li> <li>• Royal Society for the Prevention of Cruelty to Animals (RSPCA) WA Inc</li> <li>• A cat management facility</li> <li>• A veterinary clinic or veterinary hospital</li> </ul> <p>A cat that is in foster care is exempt from registration if the cat has been placed into foster care by either the Cat Haven, the RSPCA WA or by SAFE (Saving Animals From Euthanasia), and providing the cat has not been in foster care for more than a total of 12 weeks.</p>
